Privacy Policy

To send periodic emails

unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email or User may contact us via our Site.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Site.

Sensitive and private data exchange between the Site and its Users happens over a SSL secured communication channel and is encrypted and protected with digital signatures.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above. We may use third party service providers to help us operate our business and the Site or administer activities on our behalf, such as sending out newsletters or surveys. We may share your information with these third parties for those limited purposes providing that you have given us your permission.

Mobile Subscriber Information

We will NOT share, trade, sell, or rent your cell phone information with other parties under any circumstances. This includes no sharing with third parties, affiliates, or for marketing or promotional purposes.

Text Messages

Opting into text messages authorizes Transcom Telecommunications to communicate with existing customers of record for service requests and maintenance alerts only. All messages will be logically and topically related to your interaction with our services and products. In accordance with the 2024 TCPA guidelines, your participation in our SMS service requires explicit one-to-one consent. This means that by opting in, you consent to receive messages from Transcom Telecommunications only. Consent cannot be shared with other companies or third-party entities without your direct approval. Messages and Data rates may apply.

Opt Out Process

You can opt out of our SMS service at any time by replying with "STOP" to any message you receive from us. Recording Keeping and Compliance

We maintain records of when and how you provided consent to receive SMS messages. This includes storing opt-in and opt-out dates and timestamps. These records are maintained in compliance with TCPA regulations and may be used to demonstrate proof of consent if required.
